#### Method 3: Rapid Reset Tool

The Rapid Reset process must be done by a professional electrician qualified by RAB. Reach out to your RAB sales manager to request a Rapid Reset Tool. The tool simply needs to be placed directly on the small Lightcloud Blue logo on the device for 2s or until the lamp/luminaire flashes 3x, then resets to 100% brightness at the default CCT.


