Factory Reset:

Method 1: Delete from App
 Open the app and access the device settings for the paired device. Be sure that the device is online and select 'Delete'.
 Method 2: Manual
 Press and hold down the button located at the top of the Controller for 10 seconds or until the fixture flashes on/off 3x. The Controller will flash red to confirm it has been reset and is ready to pair to the App

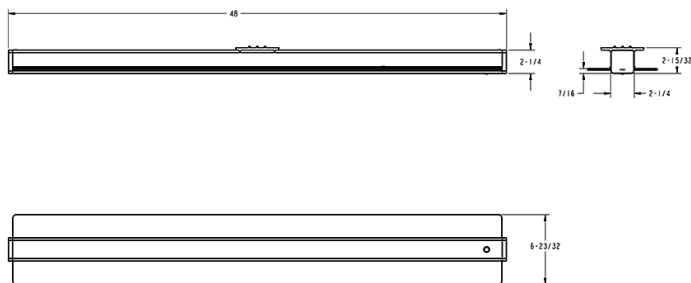
